Re: <u>Delegation to Peel Regional Council – ACER reports on Project Crossroads</u>

I am pleased to provide this Letter of Support to ACER (Association for Canadian Educational Resources) by summarizing its success to deliver Project Crossroads urban reforestation initiative in October 2020, as a contribution of climate change labs to the Knightsbridge area of Bramalea SNAP (Sustainable Neighbourhood Action Program).

ACER's results and impacts were presented to Peel Regional Council as a proof-in-concept to address a trifecta of equity crises called out with unanimously adopted Declarations in 2019 and 2020:

Climate change is a crisis. Racism is a crisis. COVID-19 is a crisis.

Project Crossroads engaged the heat-prone racialized and vulnerable residents of Knightsbridge in pandemic-adapted climate action to bring cooling shade, outdoor activities and social reconnection to an area most-impacted by COVID caseload by postal code.

ACER's collaboration with Bramalea SNAP was funded with \$20,000 US by Arbor Day Foundation under TD Green Space program. Bramalea SNAP is a collaboration of Toronto Region Conservation Authority, City of Brampton and Peel Region — Healthy Community Initiative. It is an urban revitalization program intended to engage community with local government services in order to address social inequities.

ACER'S sites are prioritized by GIS data for low tree canopy, high heat vulnerability, higher reported crime, disproportionately higher newcomer / racialized populations and with households of lowest decile income.

ACER's December 10 delegation to Peel Regional Council opened with a 2-minute video of volunteers' testimonials. Volunteers of all ages and backgrounds were very enthusiastic to play a role to protect nature, support healthier families and become a more resilient community. Links are provided.

Results and Impacts are summarized:

RESULTS: October 2020, under COVID

- 5 planting events in 3 Knightsbridge locations
- 71 volunteers, include secondary students
- 153 large trees + native pollinator/bird shrubs (biomass equivalent to 1840 x 1-gallon 18" trees)

IMPACT:

- Mulch-Measure-MOR units w/ training videos
- · Extend Million Trees program with mulch delivery
- Animate non-profit agency ecosystem
- Introduce Carbon Calculation for GHG emission

<u>ACER's Fall/Winter 2020 Newsletter</u> notes additional successes. Sheridan College students completed program hours and produced a research paper which tagged and mapped 408 trees on William Davis Campus and calculated their carbon sequester. Graduation deferred by spring 2020 pandemic crisis was accomplished in December 2020.

Public school boards continue to be restricted under pandemic protocols from holding school yard tree plantings. ACER offers students and families and remote teachers its outdoor ecology curriculum, Mulch, Measure and MOR (Measure Our Resources)) with ACER's training videos and digital resources available at no cost to the user from the website. Project Crossroads activities helped to refresh municipal forestry delivery of mulch to public school properties for students' learning.

Ahead of the delegation to Peel Regional Council, other municipal and civic committees received ACER's final report. Refef to attached Schedule "A".
